In considering our waybill access request, we have determined that we would also like to request the BNSF waybill sample data as well for 1994 to 2013. That way, we can compare the same data for the various carriers on an "apples-to-apples" basis. For 1994 and a year or two thereafter, the data will be for BN and ATSF separately since the BN/ATSF merger was not approved until 1995 and implemented thereafter. Much of this additional data was covered by the KCSR requests (1994 and 1995 were not).

Please let me know if we need to send in a supplemental letter or if this e-mail will suffice.
