


Pursuant to 49 C.F.R. 1104.7(b), CSX Transportation, Inc. (“CSXT”) respectfully requests an extension of 18 days until January 16, 2015 to respond to the Supplement to Petition for Declaratory Order of JGB Properties, LLC (“JGB”) filed on December 9, 2014.

The Supplement raises fact specific factual allegations that require CSXT to explore the facts underlying the removal of an apparent 39-foot piece of track. Because it is the end of the year, many of the employees that CSXT must confer with are taking vacation over the holidays.

CSXT has conferred with counsel for Ironwood, LLC, and Steelway Realty Corporation, and they consent to the requested extension. CSXT has also conferred with counsel for JGB and it does not oppose the requested extension.


