Dear Ms. Brown:

I am writing on behalf of Iowa Pacific Holdings, LLC ("IPH"), a short line railroad holding company, for leave to intervene in the above-captioned proceeding involving the legality of the embargo imposed by Grenada Railway, LLC ("Grenada") in FD 35247, Sub-No. 1. In addition, by this letter I am writing to confirm IPH's status as an intervener in the principal proceeding involving the revocation of Grenada's exemption from the acquisition and operation of the subject line of railroad. IPH anticipates that it will be participating in support of any feeder line application that may be filed involving the entirety of Grenada's operation between Southaven and Canton, MS, a distance of some 175 miles, as well as any connecting trackage subject to these proceedings. It is my impression that the embargo proceeding is ongoing and that the revocation proceeding is not completely resolved.

By this letter, I am also requesting that counsel for Grenada furnish the undersigned counsel and such outside consultants as may be engaged copies of all highly confidential or confidential documents furnished in both cases. I have furnished counsel for Grenada executed undertakings and have been refused copies of these
