Pursuant to 49 C.F.R. § 1104.7(b), Grenada Railway, LLC respectfully requests a two-week extension, from September 30, 2013, to October 15, 2013, of the date by which it must file the information requested by the Board by its Decision, served September 10, 2013. Among other things, the response will require an examination of four years' bills of lading in the files of the Grenada Railway, LLC or their customers, and the 20 days the Board allowed for the search for the documents simply is insufficient. Of course, if the Board were to grant the railroad's request, interested persons would have an additional two weeks, until November 4, 2013, to file replies.


