AMENDED VERIFIED NOTICE OF EXEMPTION
Pursuant to 49. C.F.R. § 1180.2(d)(2)

Watco Holdings, Inc. (“Watco”), files this Amended Notice of Exemption, pursuant to 49 C.F.R. § 1180.2(d)(2), for Watco to continue in control of Kanawha River Railroad, L.L.C. (“KNWA”), currently a non-carrier, upon KNWA becoming a Class III railroad. In support of this Notice of Exemption, Watco submits the following information as required by 49 C.F.R. § 1180.4(g):

Section 1180.6(a)

- (1) A description of the proposed transaction.
 - (i) A brief summary of the proposed transaction, the name of applicants, their business address, telephone number, and the name of counsel to whom questions regarding the proposed transaction can be addressed.

Watco, a non-carrier which currently controls indirectly thirty-three (33) Class III railroads and one (1) Class II railroad, collectively operating in 23 States. Watco also owns, indirectly, 100 percent of the issued and outstanding stock of KNWA, a limited liability company and a non-carrier that was formed for the purpose of leasing nine rail line segments in Ohio and West Virginia owned by Norfolk Southern Railway Company (“NS”). Concurrently

with the filing of this Notice of Exemption, KNWA is filing a Verified Notice of Exemption in Docket No. FD 36028, *Kanawha River Railroad L.L.C. – Lease Exemption Containing Interchange Commitment – Norfolk Southern Railway Company* under 49 C.F.R. § 1150.31 et seq., for Board authorization to undertake the aforementioned lease transactions. Upon consummation of the transaction in Docket No. FD 36028, KNWA will become a Class III carrier.

Watco also controls, through stock ownership and management, the South Kansas and Oklahoma Railroad L.L.C. (“SKO”); Palouse River & Coulee City Railroad, L.L.C. (“PRCC”); the Timber Rock Railroad, L.L.C. (“TIBR”); the Stillwater Central Railroad, L.L.C. (“SLWC”); the Eastern Idaho Railroad, L.L.C. (“EIRR”); Kansas & Oklahoma Railroad, L.L.C. (“K&O”); the Pennsylvania Southwestern Railroad, L.L.C. (“PSWR”); the Great Northwest Railroad, L.L.C. (“GNR”); the Kaw River Railroad, L.L.C. (“KRR”); the Mission Mountain Railroad, L.L.C. (“MMT”); the Mississippi Southern Railroad, L.L.C. (“MSRR”); the Yellowstone Valley Railroad, L.L.C. (“YVRR”); the Louisiana Southern Railroad, L.L.C. (“LSRR”); the Arkansas Southern Railroad, L.L.C. (“ARSR”); the Alabama Southern Railroad, L.L.C. (“ABS”); the Vicksburg Southern Railroad, L.L.C. (“VSOR”); the Austin Western Railroad, L.L.C. (“AWRR”); the Baton Rouge Southern Railroad, L.L.C. (“BRSR”); the Pacific Sun Railroad, L.L.C. (“PSRR”); the Grand Elk Railroad, Inc. (“GER”); Alabama Warrior Railway, L.L.C. (“AWR”); Boise Valley Railroad, L.L.C. (“BVR”); Autauga Northern Railroad, L.L.C. (“ANRR”); Swan Ranch Railroad, L.L.C. (“SRRR”); Wisconsin & Southern Railroad, L.L.C. (“WSOR”); Birmingham Terminal Railway, L.L.C. (“BRS”); the Ann Arbor Railroad, Inc. (“AA”); the Pecos Valley Southern Railway (“PVS”); San Antonio Central Railroad, L.L.C. (“SAC”); Blue Ridge Southern Railroad, L.L.C. (“BLU”); Lubbock and Western Railway,

L.L.C. (“LBWR”); Bogalusa Bayou Railroad, L.L.C. (“BBRR”); Texas and New Mexico Railway, L.L.C. (“TXN”); and Cicero Central Railroad, L.L.C. (“CERR”). SKO, PRCC, TIBR, SLWC, EIRR, K&O, PSWR, GNR, KRR, MMT, MSRR, YVRR, LSRR, ARSR, ABS, VSOR, AWRR, BRSR, PSRR, GER, AWR, BVR, ANRR, SRRR, BRS, AA, PVS, SAC, BLU, LBWR, BBRR, TXN and CERR are Class III carriers which operate rail lines in 23 States. WSOR is a Class II carrier operating in 2 States.

The rail lines operated by SKO, PRCC, TIBR, SLWC, EIRR, K&O, PSWR, GNR, KRR, MMT, MSRR, YVRR, LSRR, ARSR, ABS, VSOR, AWRR, BRSR, PSRR, GER, AWR, BVR, ANRR, SRRR, BRS, WSOR, AA, PVS, SAC, BLU, LBWR, BBRR, TXN, and CERR do not connect with the rail lines being leased by KNWA. The rail lines that are being leased by KNWA are located in Ohio and West Virginia. No other Watco railroad is located near the lines that KNWA proposes to lease.

The subject transaction is not part of a series of anticipated transactions that would connect the rail lines that will be operated by KNWA with the lines of any other railroad in the Watco corporate family. Finally, neither KNWA nor any of the carriers controlled by Watco are Class I rail carriers. Accordingly, this transaction falls within the class of transactions described at 49 C.F.R. § 1180.2(d)(2), and it is therefore exempt from prior approval by the Surface Transportation Board.

- (ii) The proposed time schedule for consummation of the proposed transaction.

Watco intends to consummate this transaction on or shortly after the effective date of this notice.

- (iii) The purpose sought to be accomplished by the proposed transaction.

Watco intends to reduce overhead expenses, coordinate billing, maintenance, mechanical and personnel policies and practices of its rail carrier subsidiaries and thereby improve the overall efficiency of rail service provided by the railroads in the Watco corporate family.

- (2) A list of the State(s) in which any part of the property of each applicant carrier is situated.

SKO's lines are located in Missouri, Kansas and Oklahoma.

EIRR's lines are located in Idaho.

PRCC's lines are located in Washington, Oregon and Idaho.

TIBR's lines are located in Texas and Louisiana,

SLWC's lines are located in Oklahoma.

K&O's lines are located in Kansas and Colorado.

PSWR's line is located in Pennsylvania.

GNR's lines are located in Idaho and Washington.

KRR's lines are located in Kansas and Missouri.

MMT's lines are located in Montana.

MSRR's line is located in Mississippi.

YVRR's lines are located in Montana and North Dakota.

Maps illustrating the rail lines of SKO, PRCC, TIBR, SLWC, EIRR, K&O, PSWR, GNR, KRR, MMT, MSRR, YVRR, LSRR, ARSR, ABS, VSOR, AWRR, BRSR, PSRR, GER, AWR, BVR, ANRR, SRRR, WSOR, BHRR, SAC, PVS, BLU, BBRR, LBWR, TXN and CERR and the rail lines to be operated by KNWA are attached as Exhibit A.

(4) Agreement.

Watco will not enter into any agreement, or sign any written instrument, to continue in control of KNWA.

SKO, PRCC, TIBR, SLWC, EIRR, K&O, PSWR, GNR, KRR, MMT, MSRR, YVRR, LSRR, ARSR, ABS, VSOR, AWRR, BRSR, PSRR, GER, AWR, BVR, ANRR, SRRR, BHRR, SAC, PVS, AA, BLU, BBRR, LBWR, TXN and CERR are Class III carriers, and KNWA will become a Class III carrier. WSOR is a Class II carrier. Because the transaction involves the control of one or more Class III rail carriers and one Class II rail carrier, the transaction is subject to the labor protective requirements of 49 U.S.C. § 11326(b) and *Wisconsin Central LTD. -Acquisition Exem. - Union Pac. RR*, 2 S.T.B. 218 (1997).

ENVIRONMENTAL AND HISTORIC IMPACTS

Watco will continue to control KNWA for the purpose of continued rail operations. Further Board approval would be required to abandon any service, and there are no plans to dispose of or alter properties subject to the Board's jurisdiction that are 50 years old or older. Hence, this Notice of Exemption does not require an historic report under 49 C.F.R. § 1105.8(b)(1).

Watco's continuance in control of KNWA will not result in significant changes in carrier operations. There will not be a diversion of: (1) more than 1,000 rail carloads a year to motor carriage; or (2) an average of 50 carloads per mile per year for any part of these lines to motor

carriage. This transaction will not result in: (1) an increase in rail traffic of at least 100 percent or an increase of at least eight trains a day on any segment of the lines; (2) an increase of rail yard activity of at least 100 percent; or (3) an average increase in truck traffic of more than 10 percent of the average daily traffic or 50 vehicles a day. This transaction will not affect a Class I or nonattainment area under the Clean Air Act. In any event, the thresholds of 49 C.F.R. § 1105.7(e)(5)(ii) will not be exceeded. Finally, this transaction does not contemplate the transportation of any ozone depleting materials. Therefore, no environmental documentation is required under 49 C.F.R. § 1105.6(c)(2).

This action will not significantly affect either the quality of the human environment or energy conservation.


