
Dear Ms. Brown:

By decision served in the above-captioned proceeding on August 20, 2015, R.J. Corman Railroad Company/Allentown Lines, Inc. ("RJC") was granted permission to abandon a line of railroad, located near milepost 93.18 and beginning at the south side of the Union Street Crossing (DOT marker 361714K), in Allentown, Pennsylvania and extending north to milepost 96.709, in or near Whitehall, Pennsylvania, a total distance of approximately 3.5 miles. RJC's abandonment exemption became effective on September 18, 2015.

Pursuant to 49 C.F.R. §§ 1152.29(e)(2) and 1152.60(e), RJC hereby provides notice that it exercised the authority granted herein and consummated abandonment of the subject line of railroad on December 11, 2015.
