**VERIFIED NOTICE OF EXEMPTION**

---

The Missouri Central Railroad Company (“MCRR”) and Central Midland Railway Company (“CMR”) hereby submit this joint Verified Notice of Exemption (“Notice”) pursuant to 49 USC § 10502 and 49 CFR § 1152.50 for the discontinuance of trackage rights over a rail line (“Line”) owned by the Union Pacific Railroad Company (“UP”) between Pleasant Hill, MO (at milepost 263.5) and Leeds Junction, MO (at milepost 288.3). This Notice is filed to replace both a Notice of Exemption filed by MCRR on October 17, 2013 and an Amended Notice of Exemption filed by MCRR on October 30, 2013.

In support of the Notice, MCRR and CMR respectfully provide the following information to the Surface Transportation Board (“Board” or “STB”) in accordance with 49 CFR § 1152.50(d)(2):

**I. Proposed consummation date.**

The proposed consummation date is January 7, 2014, which is at least 50 days after the filing of this Notice, as required by § 1152.50(d)(2).

**II. Certification required by 49 CFR § 1152.50(b).**

As the attached certifications by MCRR President Robert Neff and CMR CEO Lon Van Gemert confirm, neither MCRR nor CMR have originated traffic, terminated traffic, or moved overhead traffic on the Line for at least two years, and no complaint is pending with the Board or a U.S. District Court or has been decided in favor of a complainant concerning cessation of service over the Line within the last two years. See Exhibits A and B.

**III. Information required in 49 CFR §§ 1152.22(a)(1) through (4), (7), (8), and (e)(4).**

**(a)(1) – exact name of applicants**

Missouri Central Railroad Company (“MCRR”)

Central Midland Railway Company (“CMR”)

**(a)(2) – whether applicants are common carriers by railroad subject to 49 USC Subtitle IV, chapter 105**

MCRR and CMR are both common carriers by railroad subject to 49 USC Subtitle IV, chapter 105.

**(a)(3) – relief sought**

MCRR and CMR seek to use the class exemption described in 49 CFR § 1152.50 in order to discontinue trackage rights on a rail line owned by Union Pacific Railroad Company between Pleasant Hill, MO (milepost 263.5) and Leeds Junction, MO (milepost 288.3). MCRR obtained its trackage rights as part of the transaction involved in STB Docket 33508, Missouri Central

Railroad Company – Acquisition and Operation Exemption – Lines of Union Pacific Railroad Company.

CMR similarly seeks to use the class exemption described in 49 CFR § 1152.50 in order to discontinue trackage rights on the same rail line owned by Union Pacific Railroad Company between Pleasant Hill, MO (milepost 263.5) and Leeds Junction, MO (milepost 288.3). CMR mentioned these trackage rights in an operation exemption proceeding in STB Docket No.

33988, Central Midland Railway Company – Operation Exemption – Missouri Central Railroad Company.

Neither MCRR nor CMR have ever utilized these trackage rights. No local or overhead traffic has operated on the Line for at least two years.

**(e)(4) – whether the property is appropriate for other public purposes**

MCRR and CMR are only discontinuing trackage rights on the Line, which is owned and operated by the Union Pacific Railroad Company. Therefore, the Line is not currently available for other public purposes. In the event that UP seeks to abandon the Line, the issue of public use will be addressed in that proceeding.

**IV. The level of labor protection.**

The interests of railroad employees who may be adversely affected by the proposed discontinuance of trackage rights will be adequately protected by the labor protective conditions in Oregon Short Line Railroad et al. – Abandonment – Goshen Branch, 360 ICC 91 (1979).

**V. Certificate that the notice requirements of §§ 1152.50(d)(1) and 1105.11 have been met.**

Certification regarding the 10-day notice requirement of § 1152.50(d)(1) is attached at Exhibit D hereto, and a copy of the notice is at Exhibit E. No certification regarding § 1105.11 is required because (1) under § 1105.6(c)(6), there is no environmental report, as MCRR and CMR are only discontinuing trackage rights and the Line continues to be owned and operated by UP; and (2) under §§ 1105.8(a) and (b), there is no historic report, as MCRR and CMR are not leasing, transferring, or selling any part of the Line, and any abandonment would require separate Board approval.


**VI. Certificate that the notice requirement of § 1105.12 has been met.**

**VII. Conclusion.**

For the foregoing reasons, MCRR and CMR state that the proposed discontinuances of trackage rights over the Line are exempt from the prior approval requirements of 49 USC § 10903 pursuant to the class exemption set forth in 49 CFR § 1152.50, and they request that the Board issue the appropriate notices.
