Due to clerical errors, CSX Transportation, Inc. ("CSXT") and the City of Waycross ("Waycross") failed to file this letter notifying the Surface Transportation Board (the "Board") of the closing of the acquisition of the rail line for trail use by December 7, 2012. CSXT and Waycross apologize for this oversight and respectfully request the Board to accept this late filing.

CSXT and Waycross jointly notify the Board pursuant to 49 CFR 1152.29(h), that on November 27, 2012, CSXT and Waycross consummated a rail banking/interim trail use agreement for the 1.08-mile rail line on CSXT's Southern Region, Jacksonville Division, Fitzgerald Subdivision between milepost AP 588.84, and milepost AP 587.76, all in Waycross, GA, in Ware County, GA (the "Line").


A map of the Line is attached.
