CSX Transportation, Inc. ("CSXT") gives notice that on or about June 13, 2015, it intends to file with the Surface Transportation Board, Washington, DC 20423, a notice of exemption under 49 CFR 1152 Subpart F-Exempt Abandonments permitting the discontinuance of service over an approximately 3.80-mile rail line on its Southern Region, Huntington Division, and Piney Creek Subdivision between railroad milepost CAV 0.0 and railroad milepost CAV 3.80, which traverses through United States Postal Service ZIP Code 25932 and 25844, in Raleigh County, WV. The proceeding will be docketed as No. AB-55 (Sub-No. 743X).
