MEMORANDUM OF ASSIGNMENT

This MEMORANDUM OF ASSIGNMENT dated as of December [18], 2014, is by and between GREENBRIER LEASING COMPANY LLC, an Oregon limited liability company ("Assignor"), and FIRST UNION RAIL CORPORATION, a North Carolina corporation ("Assignee").

The parties to this Memorandum hereby acknowledge and confirm the following:

A. Assignor, as lessor, has leased certain railroad cars more particularly described in Exhibit A attached hereto (the "Cars") pursuant to that certain Lease Agreement dated as of April 15, 2014, and Schedule No. 2 thereto (Schedule No. 2, and the Lease Agreement as it pertains to Schedule No. 2, each as amended, modified, extended, supplemented, restated and/or replaced from time to time, the "Lease") to Schlumberger Technology Corporation.

B. A Memorandum of Lease was filed with respect to Schedule No. 2 with the U.S. Surface Transportation Board on November 21, 2014, under recordation number 31496.

C. Assignor and Assignee are parties to that certain Assignment Agreement dated December [18], 2014 (the "Closing Date"), pursuant to which Assignor has assigned all of its rights, title and interest under the Lease, with respect to periods on and after Closing Date, and the Cars, to Assignee.


