**RELEASE OF SECURITY INTEREST**

Reference is made to the Memorandum of Lease and Collateral Assignment of Lease dated as of April 26, 2012 and filed with the Surface Transportation Board under Recordation Number 30425 (the "Memorandum").

The undersigned, acting on behalf of DVB BANK SE (formerly known as DVB BANK AG), as Secured Party (the "Secured Party"), as Lessor (the "Lessor"), for good and valuable consideration, the receipt and sufficiency of which are acknowledged, does hereby terminate, release and discharge any and all security interests held by it on the railroad equipment specified in the Memorandum including the railcars specified below (the "Cars") and the Lease thereof specified below (the "Lease"), which were granted by Compass Rail VI Corporation to the Secured Party as Agent pursuant to the Loan and Security Agreement, dated as of March 20, 2007 (the "Security Agreement"), as amended, modified and supplemented, between Compass Rail VI Corporation, as Assignor and the Secured Party.

**The Cars:** Four (4) 5850 cubic foot capacity, 100-ton (263,000 lb. gross rail load) "plastic pellet" covered hopper cars equipped with interior coating, vented hatches and pneumatic outlet gates set forth bearing the following marks:



