MEMORANDUM OF LEASE

SCHEDULE NO. 1

This is a Memorandum of a Schedule No. 1, dated as of April 1, 2014, to a Lease Agreement, dated as of April 1, 2014, by and between Greenbrier Leasing Company LLC, an Oregon limited liability company, ("Lessor") and Cargill, Incorporated, a Delaware corporation ("Lessee").

WITNESSETH:

1. Lessor has agreed to furnish to Lessee, and the Lessee has agreed to lease from Lessor twenty-six (26) 5,150 to 5,701 cubic foot capacity covered hopper railcars bearing reporting marks and numbers as indicated in the attached Rail Equipment List.




