

MEMORANDUM OF LEASE

This MEMORANDUM OF LEASE is made and entered into as of April 14, 2014, between NorLease, Inc., a Delaware corporation ("**Lessor**"), and Olin Chlor Alkali Logistics, Inc., a Delaware corporation ("**Lessee**"), with reference to the following:

1. Pursuant to a Railroad Equipment Lease, dated as of March 24, 2014, between Lessor and Lessee (together with the Schedules thereto, the "**Lease**"), and Schedule No. 1 thereto, dated as of April 14, 2014 (the "**Schedule**"), Lessor agreed to lease to Lessee, and Lessee agreed to lease from Lessor, the railcars identified on Schedule I hereto (each, a "**Car**" and, collectively, the "**Cars**").

2. The Lease shall be effective as of the date hereof and shall be subject to the term specified in the Lease, and any extension of such term to the extent provided for in the Lease.

3. This Memorandum of Lease may be executed in any number of counterparts, each executed counterpart constituting an original but all together only one Memorandum of Lease.




