

**MEMORANDUM OF ASSIGNMENT OF LEASE AGREEMENT**

This **MEMORANDUM OF ASSIGNMENT OF LEASE AGREEMENT**, dated as of this 1st day of May, 2016, is made by and between **BNP Paribas (Canada)**, (the “Assignor”), and **BNP Paribas, acting through its Canada branch** (the “Assignee”).

WITNESSETH:

1. The Assignor has leased to Canadian National Railway Company, as lessee (the “Lessee”) twenty (20) SD75I diesel-electric locomotives marked CN 5781 through CN 5800 as more particularly described in Schedule A attached hereto (the “Locomotives”) pursuant to that certain Lease of Railroad Equipment dated as of February 28, 2000 (the “Lease”), as amended and supplemented, between the Assignor (as successor in interest to Bank of Montreal Global Capital Solutions Ltd.) and the Lessee. A Memorandum of the Lease was duly filed and recorded with the Surface Transportation Board (the “Board”) on February 28, 2000 at 3:33 p.m. and was assigned recordation number 22794.

2. The Assignor and the Assignee are parties to that certain Purchase and Sale Agreement, dated as of May 1, 2016, pursuant to which Assignor has granted, bargained, sold, assigned, conveyed, transferred, and delivered to Assignee all of Assignor’s right, title and interest in the Locomotives described in Schedule A attached hereto. The terms of the sale are more particularly set forth in the above-referenced document.

3. The Assignor and the Assignee are parties to that certain Assignment of Lessor’s Interest in Lease of Railroad Equipment, dated as of May 1, 2016, pursuant to which the Assignor has assigned to the Assignee all of the Assignor’s right, title and interest in, to and under and all of Assignor’s obligations under the Lease. The terms of the assignment are more particularly set forth in the above-referenced document.

3. The Assignor and the Assignee wish to show for the public record, through this Memorandum, the existence of these agreements and their respective interests therein. Accordingly, the parties have caused this Memorandum to be executed by their officers thereunto duly authorized, as of the date first written above. This Memorandum may be executed in counterparts, each such counterpart shall be binding on both parties hereto, notwithstanding that all parties are not signatories to the same counterparts.






