THIS MEMORANDUM OF COLLATERAL ASSIGNMENT OF SCHEDULES 008, 011, 013, 014 AND 015 is made and entered into as of October 16, 2015 (this "**Memorandum**"), by and among SUNTRUST EQUIPMENT FINANCE & LEASING CORP. (together with its successors and assigns, "**Secured Party**") and TRINITY CHEMICAL LEASING, L.L.C., as debtor ("**Debtor**"), with reference to the following:

1. Pursuant to a Collateral Assignment of Lease Schedule Nos. 008, 011, 013, 014 and 015 dated as of October 16, 2015 (the "**Assignment**"), Debtor has collaterally assigned to Secured Party all of Debtor's right title and interest in and to Lease Schedule No. 008 dated as of July 31, 2015, Lease Schedule No. 011 dated as of August 28, 2015, Lease Schedule No. 013 dated as of September 11, 2015, Lease Schedule No. 014 dated as of September 18, 2015, and Lease Schedule No. 015 dated as of September 23, 2015, which by their terms incorporate by reference the provisions of that certain Master Railcar Lease Agreement dated as of January 1, 2015 (collectively, the "**Lease**"), between Debtor, as lessor, and Trinity Chemical Industries, L.L.C., as lessee ("**Lessee**"), pursuant to which Lessor leased to Lessee the rail equipment described on Schedule A attached hereto (the "**Railcars**")
2. The Assignment shall be effective as of the date first set forth above and Debtor's and Lessee's use of the Railcars shall be subject to the terms and conditions as set forth in the Assignment.

This Memorandum may be executed in any number of counterparts, each executed counterpart constituting an original but all together only one Memorandum of Collateral Assignment of Lease Schedules 008, 011, 013, 014 and 015.
