MEMORANDUM OF ASSIGNMENT AND ASSUMPTION AGREEMENT

AMONG

FTS INTERNATIONAL SERVICES, LLC

AND

FML TERMINAL LOGISTICS, LLC

AND

FAIRMOUNT MINERALS, LTD.

AND

MITSUI RAIL CAPITAL, LLC

Memorandum of Assignment and Assumption Agreement made and entered into as of September 6, 2013, by and between FTS International Services, LLC, formerly known as Frac Tech Services, LLC, ("*FTSI*" or "*Assignor*"), a Texas limited liability company, FML Terminal Logistics, LLC ("*FML*"), an Ohio limited liability company, Fairmount Minerals, Ltd ("*Fairmount*"), a Delaware corporation, (FML and Fairmount collectively "*Assignee*") and Mitsui Rail Capital, LLC ("*Lessor*"), a Delaware limited liability company.

WITNESSETH:

1. Lessor leased to Assignor ("*Lessee*") two hundred (200) railcars, marked and numbered FTIX 1400 through FTIX 1599, both inclusive (the "*Cars*"), pursuant to that certain Net Lease Agreement dated November 9, 2011 (the "*Lease*"), and Schedule No. 2 thereto dated November 9, 2011 (the "*Schedule*") (the Schedule and the Lease collectively, the "*Lease Agreement*").
2. In connection with the Lease: a Memorandum of Net Lease Agreement was recorded with the Surface Transportation Board on April 23, 2012 and assigned Recordation No. 30185.
3. Subsequently, FTSI and Fairmount entered into a definitive agreement for the sale of FTSI's assets, and assignment of FTSI's contracts, to Fairmount (the "*Transaction*").
4. In connection with the Transaction, Assignor has agreed to assign to Assignee and Assignee has agreed to accept from Assignor the Lease Agreement and the Cars (the "*Assignment*").
5. In acknowledgement of the Assignment, this Memorandum of Assignment and Assumption Agreement may be executed by the parties hereto in any number of counterparts, and all counterparts taken together shall be deemed to constitute one instrument.
