THIS TERMINATION (this "Termination") dated as of July 28, 2016 is by MIDWEST RAILCAR CORPORATION (as successor-by-assignment to General Electric Railcar Services Corporation) ("Lessor").

Lessor was leasing railcars to Perdue AgriBusiness Incorporated, as lessee ("Lessee") pursuant to that certain Rider No. 1 dated September 1, 2007 (the "Rider"), incorporating the terms of that certain Car Leasing Agreement No. 6992-97-0 dated May 22, 2006, each by and between Lessee, as lessee, and Lessor, as successor lessor (the Rider, incorporating such Master Railcar Lease as it relates to the railcars listed therein, the "Lease").
