**NOTICE OF TERMINATION OF  
BAREBOAT CHARTER AGREEMENT AND  
MEMORANDUM OF BAREBOAT CHARTER**

**THIS NOTICE OF TERMINATION OF BAREBOAT CHARTER AGREEMENT AND MEMORANDUM OF BAREBOAT CHARTER** (this “Notice of Termination”), dated and effective as of October 31, 2016, is made by REGIONS EQUIPMENT FINANCE, LTD., an Alabama limited partnership, with offices at 1900 5<sup>th</sup> Avenue North, Suite 2400, Birmingham, Alabama, 35203 (hereinafter, together with its successors and assigns, “Owner”), and pertains to that certain Master Bareboat Charter Agreement, and to Schedule 001 thereto, each dated as of September 25, 2009 (collectively, the “Bareboat Charter”), between Owner and MARQUETTE TRANSPORTATION COMPANY, LLC, a Delaware limited liability company, with offices at 150 Ballard Circle, Paducah, Kentucky, 42001 (hereinafter, “Charterer”).

**WITNESSETH:**

**WHEREAS**, Owner and Charterer entered into the Bareboat Charter whereby Owner agreed to charter to Charterer, and Charterer agreed to hire from Owner, twenty (20) United States documented, 200’ x 35’ x 13’ inland hopper barges (as more fully described in the Bareboat Charter and in the Memorandum of Bareboat Charter referenced below, the “Vessels”); and

**WHEREAS**, in order to evidence the Bareboat Charter of the Vessels, Owner and Charterer entered into that certain Memorandum of Bareboat Charter Party, dated as of September 25, 2009, which Memorandum was recorded with the Surface Transportation Board on October 13, 2009 at 11:50 p.m. under Watercraft Recordation No. W-116; and

**WHEREAS**, the Bareboat Charter has been terminated.

**NOW, THEREFORE**, Owner, desiring to clarify the public record, states as follows:

1. This Notice serves as notice that the Bareboat Charter between Owner and Charterer, as evidenced by the Memorandum of Bareboat Charter filed with the Surface Transportation Board, has been terminated.
2. Owner wishes to record this Notice of Termination of Bareboat Charter and Memorandum of Bareboat Charter in order to terminate the Memorandum of Bareboat Charter of record and to release its lien with respect to the Vessels.
3. This notice is without prejudice to the rights and obligations of the parties under the Bareboat Charter which are intended to survive the termination of the Bareboat Charter, including, but without limitation, any and all indemnity rights and obligations.
