REGULATIONS GOVERNING FEES FOR SERVICES PERFORMED IN
CONNECTION WITH LICENSING AND RELATED SERVICES-
2002 UPDATE

Decided February 28, 2002

The Board adopts the 2002 User Fee Update.

BY THE BOARD:

BACKGROUND

The Surface Transportation Board (Board) is required by the regulations at 49 CFR 1002.3 to update its user fees annually. The Board's regulation at 49 CFR 1002.3(a) provides that the entire fee schedule or selected fees can be modified more than once a year, if necessary. The Board's fees are revised based on the cost study formula set forth at 49 CFR 1002.3(d). Also, in some previous years, selected fees were modified to reflect new cost study data or changes in agency fee policy. The Board's last user fee update was issued in *Regulations Governing Fees for Services-2001 Update*, 5 S.T.B. 425 (2001) (*2001 Fee Update*).

Because Board employees received a salary increase of 4.77% in January 2002, we are updating our user fees to recover these costs. All fees, with the exception of those discussed below, will be updated based on the cost formula at 49 CFR 1002.3(d).

2002 UPDATE FACTORS

For this update, the direct labor cost data have been revised to reflect the combined 2002 Government-wide general salary and 2002 locality salary increase of 4.77% that took effect in January 2002. The Government Fringe Benefit Cost used in the update formula remains at 49.55%. Based on the Board's fiscal year (FY) 2001 actual budget data, the Office General and Administrative Expense Factor has increased from 23.43% to 24.76%, and the

Board's General and Administrative Expense Factor has increased from 8.37% to 9.38%. In addition, the Operations Overhead Factor, which is developed from FY 2001 payroll cost data, has dropped slightly from 24.07% to 23.99%. The 2002 full cost for each fee item developed from these factors is set forth in APPENDIX A.

FEDERAL REGISTER COST

On January 1, 2000, the cost of publishing documents in the *Federal Register* was increased to \$148 per column. The minimum cost of publishing a document also was increased to \$148. The \$148 represented an increase of approximately 4.2% over the then-existing level of *Federal Register* costs, and that increase was included in *Regulations Governing Fees for Services—2000 Update*, 5 S.T.B. 357 (2000) (*2000 Fee Update*). Based on a recent inquiry with the United States Government Printing Office, no new increase to the *Federal Register* publication cost is called for at this time. Thus, publication costs are held constant.

FEE ITEMS INCREASED BASED ON DIFFERENT CONSIDERATIONS

In *Regulations Governing Fees for Service*, 1 S.T.B. 179 (1996) (*1996 Fee Update I*), based on concerns expressed by various parties commenting in that decision, the Board determined that fees for formal complaints would be set at 10% of the full cost and would be increased gradually to the full cost level. However, because of ongoing legislative debate regarding complaint fees when the *1996 Fee Update I* was decided, the Board initially maintained all complaint fees at \$1,000.

In *Regulations Governing Fees for Service*, 1 S.T.B. 883 (1996) (*1996 Fee Update II*), the Board established fees for coal rail rate complaint cases and all other types of complaints, which did not involve rail maximum rate complaints filed by small shippers, at \$23,300 and \$2,300, respectively. Those fees became effective on January 16, 1997, and remained in effect until the Board's decision in *Regulations Governing Fees for Service—1998 Update*, 3 S.T.B. 11 (1998), at which time the fees, based on a cost-of-living update, increased to \$27,000 and \$2,600, respectively. For the 1999 User Fee update we increased the application

percentage from 10% to 20% of full cost, as we were expected to do,¹ and increased the two fee items to \$54,500 and \$5,400, respectively.

Because of continuing legislative debate over the Board's rail rate reasonableness procedures, in the *2000 Fee Update* the Board held the application percentage at 20%. However, the cost-of-living increase was applied to the direct labor costs, which resulted in the "Formal complaints filed under the coal rate guidelines" fee increasing to \$55,000 (\$500 increase over the 1999 fee) and the "All other formal complaint" fee remaining at \$5,400. Again last year, given continuing legislative debate over the Board's rail rate reasonableness procedures, we maintained the existing percentage application of 20% but applied the 2001 cost-of-living increase that we were applying across the board. Based on the 20% of full cost application, we revised fees for the two types of complaint proceedings and set them at \$57,500 (\$2,500 increase over the 2000 fee) and \$5,700 (\$300 increase over the 2000 fee), respectively.²

For the 2002 fee level, we continue to rely on the 20% of full cost application. Based on that application, the two complaint types are set at \$61,400 (\$3,900 increase over the 2001 fee) and \$6,000 (\$300 increase over the 2001 fee), respectively.³

In addition, the \$150 filing fees established in *1996 Fee Update I* for items involving trails use requests, Amtrak conveyance and compensation proceedings, appeals to Board decisions, motor carrier undercharge proceedings and labor arbitration proceedings, adopted in *1996 Fee Update II*, are maintained. Moreover, the fee for item 13, A feeder line development program, will remain at \$2,600, and fees for item 58(i), Petition for declaratory order involving a dispute over an existing rate or practice, and item 58(ii), All other petitions for declaratory order, are held at their current levels of \$1,000 and \$1,400, respectively.

¹ In keeping with the fourth recommendation found in the Department of Transportation Inspector General's Office Report (Report on Surface Transportation Board's User Fees, Report Number: CE-1999-021, Issued November 17, 1998, at 11), we increased the application fee to 20% of full cost.

² We adopted a fee for item 56(i), Formal complaints filed under the coal rate guidelines, set at \$57,500 per filing [\$287,749.20 (total 2001 cost) times 20% and then rounded]. We also adopted the fee for item 56(ii), All other formal complaints, set at \$5,700 per filing [\$28,549.20 (total 2001 cost) times 20% and then rounded].

³ For the 2002 update, we adopt a fee for item 56(i), Formal complaints filed under the coal rate guidelines, set at \$61,400 per filing [\$307,365.01 (total 2002 cost) times 20% and then rounded]. We also adopt the fee for item 56(ii), All other formal complaints, set at \$6,000 per filing [\$30,495.80 (total 2002 cost) times 20% and then rounded].

NOTICE AND COMMENT REQUIREMENT

The fee increases involved here result from only the mechanical application of the current update formula at 49 CFR 1002.3(d), which was adopted through notice and comment procedures in *Regulations Governing Fees for Services–1987 Update*, 4 I.C.C.2d 137 (1987). Moreover, this decision *does not* contain any new fee items. Therefore, we find that notice and comment are unnecessary for this proceeding. See *Regulations Governing Fees For Services–1990 Update*, 7 I.C.C.2d 3 (1990); *Regulations Governing Fees For Services–1991 Update*, 8 I.C.C.2d 13 (1991); and *Regulations Governing Fees For Services–1993 Update*, 9 I.C.C.2d 855 (1993).

REGULATORY FLEXIBILITY ANALYSIS

We certify that these rules will not have a significant economic effect on a substantial number of small entities because the Board's regulations provide for waiver of filing fees for those entities that can make the required showing of financial hardship.

It is ordered:

1. 49 CFR Part 1002 of the *Code of Federal Regulations* is amended as set forth in APPENDIX B. Notice of the final rules adopted here will be transmitted to Congress pursuant to Pub. L. 104-121 (March 29, 1996).
2. These rules are effective on April 8, 2002.

APPENDIX B

For the reasons set forth in the preamble, title 49, chapter X, part 1002, of the *Code of Federal Regulations* is amended as follows:

Part 1002 - FEES

1. The authority citation for part 1002 continues to read as follows:

Authority: 5 U.S.C. 552(a)(4)(A) and 553; 31 U.S.C. 9701 and 49 U.S.C. 721(a).

2. Section 1002.1 is amended by revising paragraphs (a) through (d), and (e)(1) and the table in paragraph (f)(6) to read as follows:

§1002.1 Fees for records search, review, copying, certification, and related services.

* * * * *

(a) Certificate of the Secretary, \$12.00.

(b) Service involved in examination of tariffs or schedules for preparation of certified copies of tariffs or schedules or extracts therefrom at the rate of \$30.00 per hour.

(c) Service involved in checking records to be certified to determine authenticity, including clerical work, etc., incidental thereto, at the rate of \$21.00 per hour.

(d) Photocopies of tariffs, reports, and other public documents, at the rate of \$1.00 per letter or legal size exposure. A minimum charge of \$5.00 will be made for this service.

(e) * * *

(1) A fee of \$53.00 per hour for professional staff time will be charged when it is required to fulfill a request for ADP data.
