The Indiana Trails Fund respectfully requests for the Surface Transportation Board to grant an extension of 180 days, to December 25, 2012, for time to continue the negotiations toward completing Interim Trail Use in the above captioned proceeding.

This matter is continuing from the decision of July 7th, 2010 and extensions thereafter (January 3, 2011; July 3, 2011; December 28, 2011, and June 28, 2012).


The property, known as the Elgin Joliet, and Eastern Railway, extends from railroad milepost 46.10 (near Indianapolis Ave and 152nd Street) to railroad milepost 48.28 (near Hohman Ave and 149th Street latitude), a distance of 2.18 miles in Lake County, Indiana. The right-of-way is part of a line of the EJE Ry proposed for abandonment in STB Docket No. AB- 117 (Sub-No. 7X).

I certify that I am simultaneously serving this request to extend railbanking to the Elgin Joliet and Eastern Railway via the Canadian National RR Law Department, in the person of Mr. Thomas J.
