
Pursuant to 49 CFR 1104.7(b), CSX Transportation, Inc. (“CSXT”) respectfully requests the Surface Transportation Board to grant a seven-day extension to file its reply to the Petition of the City of Chicago and Village of Evergreen Park to Reopen and to Impose Sanctions (the “Petition”) that was filed on February 12, 2016, immediately prior to the three-day Presidents’ weekend.

CSXT did not receive the approximately 398-page Petition until February 16, 2016. In order to have sufficient time to respond to the Petition, counsel for CSXT consulted with counsel for the Petitioners about an extension of time for CSXT to respond. 
