NOTICE TO THE PARTIES:

Members of the United States Congress and Governors are not parties of record and, therefore, need not be served with copies of filings, unless any such Member of Congress or Governor has requested to be, and is designated as, a Party of Record.

All persons on the attached service list should review the list and determine whether information about their address and status (as a Party of Record or Non-Party) is correct. The list reflects the Board’s policy of allowing only one official representative per party to be placed on the service list.
