Dear Ms. Brown:

This request is filed on behalf of the City of Montgomery, which is interested in the property that an abandonment and discontinuance of operating rights for a rail line from milepost H411.50 to H413.62 for transportation purposes was filed by Norfolk Southern (NS)/Central of Georgia Railroad (CGR) and CSX. We understand that the STB issued a Notice of Intent for Trail Use or abandonment, which provided for a 180 day period in which the City of Montgomery and NS/CGR can negotiate an interim trail use/rail banking agreement.

We have been in communication with NS representatives in Montgomery and Virginia to negotiate an interim trail use/rail banking agreement since the STB action occurred. In addition, we have initiated and completed the process of getting an appraisal on the referenced property and any other relevant information needed to make a sound decision. NS/CGR has declined the initial offer of purchase and has initiated the preparation of their own appraisal. Based on continued negotiations and communications that are ongoing, the City of Montgomery hereby request an extension of the 180 day period by an additional 180 days in order to complete all tasks associated with this property transaction. Also, the City of Montgomery requests a waiver of the fee for filing this extension.
