Dear Ms. Brown:

By decision of the Director served October 13, 2016, the Board adopted a new procedural schedule for the remainder of the proceeding. On October 14, 2016, NECR provided PAS with a list of purported deficiencies in the discovery responses provided by PAS on September 13, 2016. The parties plan to confer regarding PAS's discovery responses to see if any disputes can be resolved in whole or in part. Accordingly, NECR is requesting that the date for NECR motions to compel, if necessary, be extended until November 4, 2016. Counsel for PAS has authorized me to say that PAS does not object to the extension request.

If the extension is granted, the remaining procedural schedule would be as follows:


