**RIVERVIEW TRENTON RAILROAD COMPANY—  
ADVERSE DISCONTINUANCE IN WAYNE COUNTY, MI**

**MOTION FOR EXTENSION OF TIME TO REPLY TO THE  
CITY OF RIVERVIEW'S PETITION FOR WAIVER**

Riverview Trenton Railroad Company ("RTRR") hereby requests an extension of time until Thursday, January 15, 2015, to reply to the Petition for Waiver filed by the City of Riverview, Michigan. Counsel for the City of Riverview ("Riverview") has advised RTRR that it does not object to the request for an extension.

On December 10, 2014, Riverview filed a Petition for Waiver from certain statutory and STB filing requirements that are required to accompany an application for adverse discontinuance or abandonment that Riverview intends to file in this proceeding. Riverview stated that it intends to file an adverse discontinuance application of service and adverse abandonment of the RTRR line of railroad in southern Wayne County, MI.

RTRR's Reply to the Petition for Waiver is currently due on December 30, 2014, during the holiday period. Counsel and key officials of RTRR are not available during this period, and an extension of time is required for RTRR to prepare its reply. Counsel for Riverview has advised RTRR that the City does not object to an extension for RTRR's reply until January 15, 2015.
