By letter filed December 30, 1996, petitioners request a further extension of time to February 21, 1997, to file their opening statements. Petitioners state that respondent does not oppose the extension requests.

The requests will be granted and the procedural schedules will be adjusted accordingly.

It is ordered:

1. Petitioners' extension requests are granted.
2. Petitioners' opening statements are due on February 21, 1997.
3. Respondent's reply is due on March 24, 1997.
4. Petitioners' rebuttal statements are due on April 14, 1997.
