OF NPRC AND OF SMART-386**

Tongue River Railroad Company, Inc. (“TRRC”) hereby moves for a two week extension of time to reply to supplemental comments submitted by Northern Plains Resource Council Inc. and Clint and Wally McRae, dba Rocker Six Cattle Company, Inc. (jointly, “NPRC”) dated March 26, 2015, and the supplemental comments of Jay L. Schollmeyer, for and on behalf of SMART-Transportation Division, General Committee of Adjustment-GO386 (“SMART-386”) dated April 9, 2015. TRRC’s reply to those comments is currently due on April 30, 2015 and TRRC is requesting that the deadline be extended to May 14, 2015.

TRRC is requesting the extension to allow its expert witness sufficient time to deal with a serious family medical situation which has understandably diverted his attention away from this proceeding. The extra time will allow the expert the time he needs to re-engage in this proceeding and allow sufficient time for the completion of the TRRC reply. Further, TRRC’s filing is the last authorized filing on the merits in this proceeding and therefore providing the requested extension will not impact any other filing deadlines.

Undersigned counsel has contacted counsel for NPRC and SMART-386 regarding this request for a two-week extension. Neither counsel object to the motion.

Accordingly, TRRC respectfully requests that this extension be granted.
