MAJOR RAIL CONSOLIDATION PROCEDURES

June 25, 2001

NOTICE TO THE PARTIES:

In the decision in this proceeding served June 11, 2001 (notice of which was published in the Federal Register on June 15, 2001, at 66 FR 32582), the Board adopted new regulations governing proposals for major rail consolidations. For technical reasons that reflect the style preferences of the Federal Register, the text of the new regulations as published in the Federal Register differs slightly from the text of the new regulations as shown in the Board's decision. To make the two versions identical, the following changes should be made to the decision served June 11, 2001.

**Change #1: Text of § 1180.1(f)(1).** At page 34 of the decision served June 11, 2001, in the second full paragraph, on line 9, delete "49 CFR 1105" and insert in lieu thereof "49 CFR part 1105".

**Change #2: Text of § 1180.1(f)(3).** At page 35 of the decision served June 11, 2001, in the first full paragraph, on line 4, after the word "submit" insert a colon (:).

**Change #3: Text of § 1180.1(h)(4).** At page 40 of the decision served June 11, 2001, in the text of § 1180.1(h)(4), on line 2 and also on line 5, delete "49 CFR 1005" and insert in lieu thereof "49 CFR part 1005".

**Change #4: Text of § 1180.1(h)(6).** At page 41 of the decision served June 11, 2001, in the second full paragraph, on line 2, delete "49 CFR 1146 and 1147" and insert in lieu thereof "49 CFR parts 1146 and 1147".

**Change #5: Text of § 1180.0(b).** At page 49 of the decision served June 11, 2001, in the first full paragraph, on line 3, delete "and will apply the prior regulations instead," and insert in lieu thereof "and instead will apply the regulations in this subpart A in effect before July 11, 2001 and contained in the 49 CFR, Parts 1000 to 1199, edition revised as of October 1, 2000,".

**Change #6: Text of § 1180.4(d)(2).** At page 53 of the decision served June 11, 2001, in the text of § 1180.4(d)(2), on line 3, delete “(38)-(41)” and insert in lieu thereof “(38) through (41)”.

**Change #7: Text of § 1180.7(b)(8).** At page 60 of the decision served June 11, 2001, in the text of § 1180.7(b)(8), on line 2, delete “the above requirements” and insert in lieu thereof “the requirements in this paragraph (b)”.

**Change #8: Text of § 1180.10(c).** At page 62 of the decision served June 11, 2001, in the text of § 1180.10(c), on line 5, delete “each facility described above” and insert in lieu thereof “each facility described in this paragraph”.

**Change #9: Text of § 1180.0(b).** At page 70 of the decision served June 11, 2001, in the paragraph containing the text of § 1180.0(b), on line 3, delete “and will apply the prior regulations instead,” and insert in lieu thereof “and instead will apply the regulations in this subpart A in effect before July 11, 2001 and contained in the 49 CFR, Parts 1000 to 1199, edition revised as of October 1, 2000.”.

**Change #10: Text of § 1180.1(f)(1).** At page 74 of the decision served June 11, 2001, in the second full paragraph, on line 9, delete “49 CFR 1105” and insert in lieu thereof “49 CFR part 1105”.

**Change #11: Text of § 1180.1(f)(3).** At page 75 of the decision served June 11, 2001, in the first full paragraph, on line 4, after the word “submit” insert a colon (:).

**Change #12: Text of § 1180.1(h)(4).** At page 76 of the decision served June 11, 2001, in the third full paragraph, on line 2 and also on line 5, delete “49 CFR 1005” and insert in lieu thereof “49 CFR part 1005.”
