JOINT MOTION TO MODIFY THE PROCECURAL SCHEDULE

The State of South Dakota acting by and through its Department of Transportation (“South Dakota” or “State”) and Canadian Pacific Railway Company (“CP”) file this joint motion asking the Board to issue an order modifying the procedural schedule by extending all dates as indicated herein, and in support hereof the parties state as follows:

1. The current procedural schedule calls for the State to file its Petition supplement today (August 22, 2014) and for CP to file its reply to that supplement on September 25, 2014.
2. The parties request that the current due dates be extended by one week. Under this revised schedule, the State’s Petition supplement would be due on August 29, 2014, and the CP’s reply would be due on October 2, 2014.
3. This request is a product of correspondence between the State and CP that occurred late yesterday, and reflects the need to adjust the schedule in light of recent communications between the State and CP.
