If the Board receives any changes/corrections to the service list, a Notice will be issued advising all parties of the changes/corrections as soon as possible because comments are due May 16, 2000, as set forth in the ANPR.

Late-filed petition for leave to late-file a notice of intent to participate. On April 21, 2000, the Board received a petition for leave to late-file a notice of intent to participate in this proceeding from Robert P. vom Eigen, counsel for the Commuter Rail Division of the Regional Transportation Authority of Northeast Illinois d/b/a "Metra." Because no party will be prejudiced by the late filing of Metra's notice of intent to participate, the petition for leave to late-file is granted and Mr. vom Eigen will be added to the service list as a Party of Record representing Metra.

Late-filed notices of intent to participate. On April 24, 2000, the Board received a request to participate from Sandra J. Dearden, President of MDCO Transportation Management, Ltd. (MDCO). Ms. Dearden's letter inadvertently references Finance Docket No. 33842; however, MDCO confirmed its intent to participate in STB Ex Parte No. 582 (Sub-No. 1). Because no party will be prejudiced by the late filing of MDCO's notice of intent to participate, the Board accepts the late-filed notice and Ms. Dearden's name will be added to the service list as a Party of Record representing MDCO.

On April 26, 2000, the Board received a request to participate from Forrest C. Hume on behalf of Canadian Resource Shippers Corporation (CRSC).² Because no party will be prejudiced

² In a letter dated April 27, 2000, Mr. Hume, who is not a member of a U.S. State bar, seeks a waiver from the Board of the qualifications and requirements set forth at 49 CFR 1103.2, so that he may represent the CRSC before the Board in this proceeding. Mr. Hume is a member of the Canadian Bar Association, the Nova Scotia Barristers' Society, the Law Society of New Brunswick, the Barreau du Quebec, and the Law Society of British Columbia. He contends that: (1) the rulemaking which is being proposed is of substantial importance to both U.S. and Canadian commerce; and (2) it would be burdensome for the CRSC to retain local counsel for the purpose of making presentations to the Board in this proceeding. The Board grants this waiver request.
