ENVIRONMENTAL ASSESSMENT

DOCKET NO. AB-534 (Sub. No. 1X)

**Lake State Railway Company -
Abandonment Exemption
Rail Line in Alpena County, Michigan**

BACKGROUND

In the above entitled proceeding, the Lake State Railway Company (Lake State) has filed a notice of exemption under 49 CFR 1152.50 seeking exemption from the requirements of 49 U.S.C. 10903 in connection with the abandonment of its line between Alpena and Hillman, between Milepost 0 to Milepost 8, a distance of 8 miles in Alpena County, Michigan. A map depicting the rail line in relationship to the area served is appended to the report. If the notice becomes effective, the railroad will be able to salvage track, ties and other railroad appurtenances and to dispose of the right-of-way.

Description of the Line

The line is located west of Alpena's downtown area and north of State Highway 23 in Alpena County. According to Lake State in its application, the line traverses forested recreational land used principally for hunting and passes over no major waterways.

In the past, Lake State transported shale to a single shipper on the line. Lake State ceased service on the line when the shipper altered its manufacturing process and no longer required shale. No traffic has moved over this line for the past two years.

ENVIRONMENTAL REVIEW

Lake State submitted an environmental report that concludes the quality of the human environment will not be affected significantly as a result of the abandonment or any post-abandonment activities, including salvage and disposition of the right-of-way. Lake State served the environmental and historical reports on a number of appropriate Federal, state, and local agencies as required by the Surface Transportation Board's environmental rules [49 CFR 1105.7(b)]. A number of agencies responded by letter and these letters were included in

Applicants' application. We have investigated the record in this proceeding.

CONDITIONS

We recommend that no environmental conditions be placed on any decision granting abandonment authority.

CONCLUSIONS

Based on the information provided from all sources to date, we conclude that, as currently proposed, abandonment of the line will not significantly affect the quality of the human environment. Therefore, the environmental impact statement process is unnecessary.

Alternatives to the proposed abandonment would include denial (and, therefore, no change in operations), discontinuance of service without abandonment and continued operation by another operator. In any of these cases, the existing quality of the human environment and energy consumption should not be affected.

PUBLIC USE

If abandonment and salvage of the rail line does take place, the right-of-way may be suitable for other public use. A request containing the requisite four-part showing for imposition of a public use condition (49 CFR 1152.28) must be filed with the Surface Transportation Board and served on the railroad within the time specified in the Federal Register notice.

TRAILS USE

A request for a notice of interim trail use (NITU) is due to the Surface Transportation Board, with a copy to the railroad, within 10 days of publication of the notice of exemption in the Federal Register. However, the Board will accept late-filed requests as long as it retains jurisdiction to do so. This request must comply with the Board's rules for use of rights-of-way as trails (49 CFR 1152.29).
