ENVIRONMENTAL ASSESSMENT

NO. AB-487 (SUB-NO. 1X)

PITTSBURGH & SHAWMUT RAILROAD, INC.
-- ABANDONMENT EXEMPTION --
IN JEFFERSON COUNTY, PENNSYLVANIA

BACKGROUND

In this proceeding, Pittsburgh & Shawmut Railroad, Inc. (PSR) has filed a petition under 49 U.S.C. 10502 seeking exemption from the requirements of 49 U.S.C. 10903 in connection with the abandonment of its railroad line located between Milepost 2.0, near Brockway, and Milepost 19.0, near Brookville, a distance of 17.0 miles in Jefferson County, Pennsylvania. A map depicting the rail line in relationship to the area served is appended to the report. If the notice becomes effective, PSR will be able to salvage track, ties and other railroad appurtenances and to dispose of the right-of-way.

DESCRIPTION OF THE LINE

The line traverses a rural area and has eight bridges believed to be 50 years old or older. Three carloads of freight were handled on the line in 1995 and 1996, and one carload in February, 1997.

ENVIRONMENTAL REVIEW

The railroads have submitted an environmental report that concludes the quality of the human environment will not be affected significantly as a result of the abandonment or any post-abandonment activities, including salvage and disposition of the right-of-way. The railroads have served the environmental report on a number of appropriate Federal, state, and local agencies as required by the Board's environmental rules at 49 CFR 1105.7(b). We have verified the record in this proceeding. The U.S. Department of Commerce, National Geodetic Survey (NGS), has identified 10 geodetic station markers that could be affected by the proposed abandonment.

CONDITION

In view of NGS' comments, we recommend that a condition be placed on any decision granting abandonment authority requiring the railroad at least 90 days prior to commencement of salvage operations to notify the National Geodetic Survey if the following geodetic station markers may be disturbed or destroyed by such operations:

CONCLUSIONS

Based on the information provided from all sources to date and subject to the recommended condition, we conclude that, as currently proposed, abandonment of the line will not significantly affect the quality of the human environment. Therefore, the environmental impact statement process is unnecessary.

Alternatives to the proposed abandonment and discontinuance of service would include denial (and, therefore, no change in operations), discontinuance of service without abandonment and continued operation by another operator. In any of these cases, the existing quality of the human environment and energy consumption should not be affected.

PUBLIC USE

If abandonment and salvage of the rail line does take place, the right-of-way may be appropriate for other public use. A request containing the requisite four-part showing for imposition of a public use condition (49 CFR 1152.28) must be filed with the Board and served on the railroad within the time specified in the Federal Register notice.

TRAILS USE

A request for a notice of interim trail use (NITU) is due to the Board, with a copy to the railroad, within 10 days of publication of the notice of the petition for exemption in the Federal Register. However, the Board will accept late-filed requests as long as it retains jurisdiction to do so. This

request must comply with the Board's rules for use of rights-of-way as trails (49 CFR 1152.29).
