**JOINT REQUEST FOR EXTENSION OF PROCEDURAL SCHEDULE**

By its stamp order served February 20, 2014, the Board adopted the revised procedural schedule for this proceeding jointly proposed by the parties. Under that schedule, the parties had intended to complete discovery by today, with opening submissions by both parties to be filed on May 29, 2014 (30 days after the close of discovery).

Applicant National Railroad Passenger Corporation (“Amtrak”) and respondents Illinois Central Railroad Company and Grand Trunk Western Railroad Company (together, “CN”) have made significant progress regarding discovery, but have determined that an extension of the procedural schedule for approximately 45 additional days is warranted in order to complete discovery.

WHEREFORE, Amtrak and CN hereby request jointly, pursuant to 49 C.F.R. § 1104.7(b), a further 45-day extension of the procedural schedule, so that the schedule as extended shall be as follows:

July 14, 2014	Due date for opening submissions by both parties;
August 18, 2014	Due date for rebuttal submissions by both parties;
September 17, 2014	Due date for opening briefs of both parties;
October 7, 2014	Due date for reply briefs of both parties.
