**REPLY TO APPEAL OF THE OFFICE OF PROCEEDINGS’
MARCH 14, 2012, DECISION REJECTING THE
OFFER OF FINANCIAL ASSISTANCE (“OFA”)**

Consolidated Rail Corporation (“Conrail”), CSX Transportation, Inc. (“CSXT”) and Norfolk Southern Railway Company (“Norfolk Southern”) (jointly “Applicants”), hereby reply to the Notice of Appeal filed by James Riffin (“Riffin”) to the Decision of the Office of Proceedings served March 14, 2012 (“Notice of Appeal”), which rejected the Offer of Financial Assistance (“OFA”) made by Riffin, Eric J. Strohmeyer (“Strohmeyer”) and CNJ Rail Corporation (“CNJ”) (“Purported Offerors”) as follows:

1. This reply is made pursuant to the provisions of 49 CFR §§ 1011.2(a)(7) and 1152.25(e).

2. Riffin's appeal is based upon two arguments: (1) that the Office of Proceedings incorrectly found that incomplete financial statements had been filed and (2) that the Office of Proceedings incorrectly held that offers to purchase less than what a railroad was seeking to abandon would be rejected. Notice of Appeal ¶ 13. Neither of those arguments have merit.

3. Riffin's appeal should be rejected by the Board first and foremost because one of its primary premises, *i.e.*, that Strohmeyer filed financial information on behalf of himself and CNJ on March 12, 2012, is a blatant misrepresentation to the Board. See Notice of Appeal at ¶¶ 9, 25, 27. Riffin's statements in this regard are belied by the statements made by Strohmeyer on behalf of himself and CNJ in his Request for Extension of Time filed on March 14, 2012, in which he stated that "your petitioners filed a request for a protective order in this proceeding so it can make available our financial materials to the Board. Your petitioners have not yet filed those materials in light of the fact that there has not yet been a ruling on the request for a protective order." *Id.* at ¶ 3. Furthermore, among the requests for relief made in the March 14 filing, Strohmeyer requests on behalf of himself and CNJ that the Board "grant the motion for a protective order in this proceeding so the Offerors can submit their financial records." *Id.* at ¶ 48(3).

4. Strohmeyer previously misrepresented to the Board that his and CNJ's financial information was being filed concurrently, under seal, with its "amended" OFA on March 13, 2012. See OFA filed March 13, 2012, at ¶¶ 31-32. That statement is likewise belied by the aforementioned statements in Strohmeyer's March 14, 2012, Request for Extension of Time.

5. The date stamp on the Purported Offerors' "draft" OFA filed on March 9, 2012 (see Notice of Appeal at ¶ 4), shows that this document was hand delivered to the Board. Therefore, Strohmeyer could have filed his financial information on March 9 in person, rather than the supposed "attempt" that Riffin states Strohmeyer made to do so electronically on March 9 and the supposed March 12 electronic filing of this information,

which were not mentioned in Strohmeyer's March 14, 2012, Request for Extension of Time.

6. In regard to Riffin's financial information, Applicants have not been provided even the outdated, bare bones summary information that Riffin apparently filed on March 14, 2012. While Riffin attempts to equate his own personal bank statements with corporate financial statements (see Appeal at ¶ 21), he offers no excuse why he could not submit a current bank statement rather than one several months old. The submission of current bank statements would be reasonable for any party, especially one who is the debtor in a still ongoing Chapter 7 bankruptcy case. See Notice of Appeal at ¶ 20, Docket Entries in Bankruptcy Case # 10-11248 attached hereto as Exhibit "A".

7. In addition to the lack of any financial information filing by Strohmeyer and CNJ, and only inadequate filing by Riffin, is the fact that Purported Offerors did not make their requests for a protective order or filing of inadequate financial information until after the deadline for filing financial information had expired. It is to be noted that the March 9, 2012, deadline for filing their OFA was a two-week extension of the original deadline of February 24, 2012, which was granted by the Board and was unopposed by Applicants. Thus, while Purported Offerors were provided ample additional time for making their filings, they completely disregarded the deadline and did not even attempt to begin the process of obtaining a protective order or filing their financial information under seal, processes of which they were certainly aware from their numerous prior filings with the Board, until after the extended deadline had passed.

8. Riffin states that good cause has been shown for Strohmeyer's and CNJ's "late filing." See Notice of Appeal at ¶ 27. He provides no excuse for his own late filing of financial information. Filing wholly inadequate financial information following an extended deadline for doing so, with excuses that their own filings show to be blatant misrepresentations, certainly does not represent "good cause."

9. Riffin's allegations of denial of due process and lack of notice of what constitutes sufficient filings of financial information also ring hollow. Certainly, the filing of incomplete, outdated and untimely filed information is insufficient under the Board's prior decisions holding that "vague and unsubstantiated assurance of [an offeror's] ability to fund, or to obtain funding, to purchase a line, and to arrange for operations for a period of two years" are cause for rejecting an OFA. See *Indiana Southwestern Railway Co. – Aban. Exemption – in Posey and Vanderburgh Counties, Ind.*, 2011 WL 1345570 at *4 (STB served April 8, 2011), citing, *Union Pac. R.R. – Aban. Exemption – in Lassen County, Cal., and Washoe County, Nev.*, AB 33 (Sub-No. 230X) (STB served Sept. 19, 2008). Assertions of financial responsibility must be supported by evidence to verify those claims, such as verified statements from a lender or verified statements of an offeror's available assets from a financial institution. *Union Pac. R.R. – Abandonment – in New Madrid, Scott, and Stoddard Counties, Mo.*, AB-33 (Sub.-No. 261) (STB served July 30, 2009).

10. The Purported Offerors are completely lacking in making the threshold showing of financial responsibility to purchase the line for fair market value and, contrary to their assertions of necessity, that they can make the further required showing of financial ability to operate the line for at least two years. See Notice of Appeal ¶ 31; 49 U.S.C. § 10904(f)(4)(A).

11. The Purported Offerors further propose to purchase only a 20-foot wide strip of land on the portion of the line owned by Conrail from MP 2.70 to MP 2.80. In support of this proposal, Riffin misstates the relevant legal standard. The *Railroad Ventures* case cited by Riffin at paragraph 36 of his Notice of Appeal concerned a prospective OFA purchaser's right to determine the property interests it sought to acquire, where the rail line owner attempted to limit the purchase to the track, related track appurtenances and a surface easement for rail purposes, rather than the full fee interest in the property as stated in the abandonment petition. See *Railroad Ventures, Inc. v. Surface Transportation Board*, 299 F.3d. 523, 550-556 (6th Cir. 2002) ("*Railroad Ventures*"). In

this regard, the Court does not take exception to the Board's interpretation of 49 U.S.C. § 10904(f)(1)(B) in an underlying decision, where the Board stated that an offeror "can opt to acquire less than the full *length* of the line where the offeror wishes to provide for continued rail service on only a portion of the line." *Railroad Ventures*, 299 F.3d at 550 (emphasis added).

12. Here, the Purported Offerors seek to acquire only that length of the line from MP 0.00 to MP 2.80, which is consistent with the rule articulated in *Railroad Ventures*. However, the Purported Offerors seek to acquire within the Conrail-owned segment from MP 2.70 to 2.80 only a 20-foot wide strip, which is so narrow it would not comply with Pennsylvania Public Utility Commission side clearance requirements. See 52 Pa. Code § 33.122(b) (requiring minimum side clearance of 12 feet from the centerline of track).

13. In the Notice of Appeal, Riffin completely ignores that the OFA states that unspecified additional property would be necessary "in order to build a side track to the industrial property adjacent to the line." Amended OFA filed March 13, 2012, at ¶¶ 38-39. Neither Conrail nor the Board is provided any indication of the quantity or location of this additional property.

14. While the offer itself is uncertain in its terms, what is certain is that if the offer were consummated, Conrail would be left with stranded parcels of property of diminished value.

15. In regard to the value of the land between MP 2.70 and 2.80, Riffin offers no appraisal or independent assessment to support his valuation of the land, nor the deed or other governmental record to support his contention that an unspecified neighboring parcel of "1+ acre" was sold for \$12,500 in November 2011, which is much less than the \$125,000 per acre value of property that Conrail has under agreement of sale for a portion of the line just north of that sought by Purported Offerors. See Notice of Appeal ¶ 38;

Exhibit "C" to Conrail's Response to Information Requests of Strohmeier and CNJ
Pursuant to Notice of Intent to File an Offer of Financial Assistance filed Feb. 7, 2012.

16. The statutory provisions of 49 U.S.C. § 10904(f)(1)(B) require that a carrier be made whole through the OFA process by receiving not less than "fair market value" of the line. The Board properly recognized that due to that statutory requirement, an offeror seeking to acquire less than the entire width of the right-of-way has a heavy burden of proof in regard to the adequacy of the right-of-way they seek for effective transportation purposes and compensation for the diminution of value of the remaining right-of-way, citing, *Union Pac. R.R. – Aban. Exemption – in Lancaster Cnty., Neb.*, AB 33 (Sub-No. 112X), slip op. 5 (STB served March 2, 1998) and *Boston & Me. Corp. & Springfield Terminal Ry. – Aban. & Discontinuance of Serv. In Hartford Cnty, Conn.*, AB 32 (Sub-No. 43) (ICC served Aug. 9, 1991). The Board properly found that the Purported Offerors in this case failed to sustain that heavy burden through their unsubstantiated assertions.

As the Purported Offerors have neither met the standard of financial responsibility for purposes of instituting negotiations nor made a *bona fide* offer for the rail property, Applicants Conrail, CSXT and Norfolk Southern respectfully request that the Board affirm the March 14, 2012, Decision of the Office of Proceedings to reject the Offer of Financial Assistance submitted by Riffin, Strohmeier and CNJ.




