V and S Railway, LLC ("V&S") is writing this letter to request that the Board extend the dates for the filing of comments to the Application, and for applicants to reply thereto.

Under the revised schedule established by the Board in its decision served June 7, 2016, comments are currently due on August 1, 2016, and applicants' reply is due on August 22, 2016. The June 7 decision also referred V&S's motion for the issuance of third party subpoenas to Administrative Law Judge John P. Dring. In an order served June 30, 2016, Judge Dring set oral argument on the motion for July 27, 2016. V&S will not know until Judge Dring issues his decision on the motion whether V&S will be authorized to issue the subpoenas, and if so, when responses will be due. Accordingly, V&S will not be able to finalize its comments until after Judge Dring rules on the motion.


V&S therefore requests that the Board extend the schedule as follows:

Verified statements and comments	(1) 7 days after an ALJ decision denying the motion for 3rd party subpoenas, or (2) if the ALJ grants the motion for 3rd party subpoenas in full or in part, 10 days after the due date set by the ALJ for responses to the subpoenas
Reply by applicants	20 days after the applicable due date for verified statements and comments

Counsel for the applicants has authorized me to state that he does not oppose the proposed change to the procedural schedule.


