



Dear Ms. Brown:

CSX Transportation, Inc. (“CSXT”) agrees to the request from the City of Fultondale filed on September 5, 2014, for an extension of 180 days to negotiate interim trail use/rail banking over the 16.47-mile rail line extending from milepost ONC 384.00 at Black Creek to milepost ONJ 400.47 at West Jefferson, in Jefferson County, AL, in the above-entitled proceeding. The period to negotiate trails use was most recently extended to August 26, 2014, and the consummation date was extended to October 25, 2014. *CSX Transportation, Inc.-Abandonment Exemption-in Jefferson County, Ala.*, STB Docket No. AB-55 (Sub-No. 613X) (STB served March 20, 2014). CSXT has not consummated the abandonment. CSXT concurs in an extension of the negotiating period until February 22, 2015. CSXT understands that the consummation date would then be extended to April 23, 2015 pursuant to 49 C.F.R. §1152.29(e)(2).
