Re: Mile Post Correction for Verified Notice of Exemption filed in Finance Docket No. 35897, R. J. Corman Railroad Company/Carolina Lines, LLC – Acquisition and Operation Exemption – The Baltimore and Annapolis Railroad Company D.B.A Carolina Southern Railroad Company.

Dear Ms. Brown:

By this letter, R. J. Corman Railroad Company/Carolina Lines, LLC (“RJC-Carolina”) provides a correction to one of the mileposts used to describe the acquired line in the above referenced Verified Notice of Exemption.

Page Four of the Notice provided that RJC-Carolina would acquire two interconnected rail lines, the first extending from milepost AL 326.0 at Mullins, SC, to milepost ACH 297.2 at Chadbourn, NC (the “Mullins-Whiteville Segment”), and the second extending from milepost ACH 297.2 at Chadbourn, NC (at a point of connection with the Mullins-Whiteville Segment) to milepost ACH 336.1 at Conway, SC (the “Chadbourn-Conway Segment”). Milepost ACH 336.1 should have been more precisely stated as ACH 336.18. As a consequence of that error, the total length of the line acquired was approximately 74.98 route miles as opposed to the 74.9 route miles recited on Page Five.

RJC-Carolina requests that the Board update its records to reflect these corrections and apologizes for any confusion it may have caused. Please feel free to contact me if you have any questions.
