

On December 29, 2014, Coffee-Brimhall LLC ("Coffee-Brimhall"), jointly with certain other parties to the aforementioned proceeding, filed a Petition for Reconsideration of the Board's December 12, 2014 Order granting Petitioner California High-Speed Rail Authority's Petition for Declaratory Order, submitted for filing on October 9, 2014.

The purpose of this letter is to advise the Board that discussions between Coffee-Brimhall and the California High-Speed Rail Authority (the "Authority") in the context of separate state court litigation have culminated in the execution of a settlement agreement between Coffee-Brimhall and the Authority, a condition of which is that Coffee-Brimhall withdraw from the Petition for Reconsideration.
