Dear Ms. Brown:

By decision served on October 2, 2007, the Surface Transportation Board (STB) issued a notice of interim trail use or abandonment (NITU) substituting the City of Fultondale, Al. (the City), as the interim trail use proponent in lieu of Jefferson County, Alabama with respect to the 16.47-mile line which is the subject of the above-referenced proceeding. The Board also authorized a new negotiation period for the City and CSXT extending from October 2, 2007, until March 30, 2008.

By decisions served on April 3, 2008, October 2, 2008, April 6, 2009, and September 28, 2009, the trail use negotiation period under the NITU was extended to March 20, 2010. These decisions also extended the consummation notice filing deadline until March 19, 2010.

During the current extension period the City and CSXT have been involved in the negotiation of a Right-of-Entry Agreement required in order for the city to conduct environmental testing under the draft Purchase Sale Agreement, and the City obtained conditional access to funds available through an EPA Brownfield Grant to cover the cost of that ESA testing work. The City has now approved and is in the process of executing the Right-of-Entry Agreement to be submitted to CSXT for its approval and execution.

"A FRIENDLY CITY"

Material progress has been made in these negotiations to-date, and the City desires an extension of the March 20, 2010 deadline in order to gain access to the site and conduct the ESA testing work to be funded through the Brownfield Grant. By copy of this letter to CSXT, I am requesting that CSXT notify you of its agreement with this requested extension of 180 days from the March 20th date. During the last extension we have received right-of-entry and have completed the environmental testing. By receiving this letter we are requesting that CSXT notify you of its agreement with this request extension of 180 days from September 15th date so we can complete the negotiations.

Since our last extension the City has made a lot of progress with our right-of-entry granted to do the environmental on the rail bed. The testing is almost complete on all but two parcels. By receiving this letter we are requesting a 180 day extension from March 15, 2011 from CSXT to complete the work and finish the negotiations.


Since our last extension request of March 15th, 2011 we have completed the Environmental on the rail bed and also the appraisal has been updated. The negotiations were on going until April 27th when an F-3, F-4 and F-5 tornado hit our state and killed 245 people. Fultondale had over 300 homes damaged, several businesses destroyed or damaged and 32 homes were completely destroyed, but we were blessed that we had no loss of life due to the destruction.

We had to put the CSXT negotiations on hold until we could help our residents and business owners put their life's back together. However, it is time to start the process again. Therefore I am requesting another 180 day extension from September 11, 2011 so we can complete the negotiations on this great project for our community.

The City of Fultondale is once again requesting a 180 day extension by the Surface Transportation Board. We have just received the third appraisal that the Surface Transportation Board and the City of Fultondale agreed upon. We feel that the final days of this negotiation is near for both parties to reach an agreement and move forward on this great Rail Corridor Project in North Jefferson County, Alabama.

Once again I would like to thank the Surface Transportation Board and all origination that have been working so long and hard on this great project.

CSX TRANSPORTATION, INC.—ABANDONMENT EXEMPTION—
IN JEFFERSON COUNTY, ALA.

Decided: March 12, 2012

CSX Transportation, Inc. (CSXT) filed a notice of exemption under 49 C.F.R. pt. 1152 subpart F—Exempt Abandonments to abandon a 16.47-mile rail line extending from milepost ONC 384.00 at Black Creek to milepost ONJ 400.47 at West Jefferson, in Jefferson County, Ala. Notice of the exemption was served and published in the Federal Register on September 22, 2003 (68 Fed. Reg. 55,085).

By decision and notice of interim trail use or abandonment (NITU) served October 21, 2003, the proceeding was reopened and a 180-day period was authorized for the Jefferson County Commission (County) to negotiate an interim trail use/rail banking agreement with CSXT for the right-of-way involved in this proceeding pursuant to the National Trails System Act, 16 U.S.C. § 1247(d) (Trails Act).¹ The trail use negotiation period under the NITU was extended several times, with the decision served April 5, 2007, extending the negotiation period until October 3, 2007.

By decision served on October 2, 2007, the Board vacated the NITU served on October 21, 2003, and issued a replacement NITU substituting the City of Fultondale, Ala. (the City), as the interim trail use proponent in lieu of the County with respect to the 16.47-mile line. The Board also authorized a new, 180-day negotiation period for the City and CSXT, extending from October 2, 2007, until March 30, 2008.

By a series of decisions, the most recent served on September 27, 2011, the trail use negotiation period under the NITU was extended to March 9, 2012. In this decision, the Board is granting the request by the City to extend further the NITU negotiating period.

By letter filed on March 2, 2012, the City submitted a request for an additional 180-day extension of the negotiating period. The City states that it has received a third appraisal involving the line and that the time is needed to complete the negotiations between the parties.

¹ That decision also imposed a salvage-related condition that remains in effect.



Dear Ms. Brown:

CSX Transportation, Inc. (“CSXT”) agrees to the request from the City of Fultondale filed on March 2, 2012, for an extension of 180 days to negotiate interim trail use/rail banking over the 16.47-mile rail line extending from milepost ONC 384.00 at Black Creek to milepost ONJ 400.47 at West Jefferson, in Jefferson County, AL, in the above-entitled proceeding. The period to negotiate trails use was most recently extended to March 9, 2012, and the consummation date was extended to May 8, 2012. *CSX Transportation, Inc.-Abandonment Exemption-in Jefferson County, Ala.*, STB Docket No. AB-55 (Sub-No. 613X) (STB served September 27, 2011). CSXT concurs in an extension of the negotiating period until September 15, 2012. CSXT understands that the consummation date would then be extended to November 14, 2012 pursuant to 49 CFR 1152.29(e)(2).
