SUPPLEMENT

Dear Ms. Brown:

On February 24, 2016, Chicago, Central & Pacific Railroad Company, Grand Trunk Western Railroad Company, Illinois Central Railroad Company, and Wisconsin Central Ltd. (collectively, the “CN Roads”) filed a notice of exemption, pursuant to the Board’s class exemption procedures at 49 C.F.R. § 1180.2(d)(7) to engage in a trackage rights transaction involving certain existing and to-be-built lines comprising the portion of a rail route commonly referred to as the Western Avenue Corridor in Chicago, IL. Attached to the class exemption filing as Exhibit A was a map schematic depicting the proposed trackage rights route.

The map originally supplied as Exhibit A to the subject notice of exemption could be read to suggest that the trackage rights operations include the right to operate over and through connections with a parallel-running railroad route of CSX Transportation, Inc. (“CSXT”) near 16th Street, near 23rd Street, near Interstate 55, and near 35th Street. To avoid any confusion, and to clarify that the CN Roads will not obtain the rights by virtue of this transaction to operate over and through each of the aforementioned connections to the lines designated on the map as those of “CSX,” the CN Roads offer this supplement attaching hereto an updated trackage rights map to replace the map included with the February 24 filing.
