Dear Ms. Brown:

In accordance with the provisions of 49 CFR 1152.29(e)(2), Jackson, Gordonville and Delta Railroad Company ("JGD Railroad") hereby notifies the Surface Transportation Board ("Board") that, pursuant to the Board's decision served on June 1, 2012, as modified by the Board's decision served on July 2, 2012, which extended the effective date of the exemption granted by the Board's initial decision until December 30, 2012, JGD Railroad has abandoned approximately 13.3 miles of rail line ("Line") situated in Cape Girardeau County, Missouri, between the Line's southern terminus at Railroad Milepost 149.4 in the City of Delta and its northern terminus at Railroad Milepost 157.9 near Gordonville.

The record in this docket reflects that JGD Railroad's request to the STB for extending until November 28, 2013, the time for filing this Notice of Consummation was approved by grant stamp served May 23, 2013. Thus, this Notice of Consummation is timely filed.

Salvage operations on the Line have been completed to the extent requested by the servient estate owners of the Line's right-of-way, and by virtue of this Notice, it is the intent of JGD Railroad that the Line be removed from the interstate rail network. A copy of this notice is being served concurrently on the Missouri Public Service Commission, the Missouri Department of Transportation and the County Clerk of Cape Girardeau County, Missouri.
