

NOTICE

Pursuant to regulations of the Surface Transportation Board (“STB”) at 49 C.F.R. § 1150.42(e), South Carolina Division of Public Railways d/b/a Palmetto Railways, a Class III rail carrier (“Palmetto Railways”), hereby gives notice to employees of CSX Transportation, Inc. (“CSXT”) and Norfolk Southern Railway Company (“NSR”) that on or about February 16, 2015, Palmetto Railways intends to commence operating the Cosgrove Yard property in North Charleston, South Carolina currently leased to North Charleston Terminal Company (“NCTC”) and operated by NCTC’s owners CSXT and NSR. The NCTC lease will expire by its terms on February 16, 2015, at which time NCTC/CSXT/NSR operation of Cosgrove Yard will cease.

A notice of exemption to authorize the proposed change in operators transaction will be filed with the STB on or before January 16, 2015 in Finance Docket No. 35881.
