PETITION FOR ABANDONMENT EXEMPTION FILED BY MICHIGAN AIR-LINE RAILWAY CO. TO THE
STB ON: JANUARY 28th, 2011.**

1. Robert Alan Kemp, D/B/A; Nevada Central Railroad, as a financially responsible individual now described and identified doing business hereinafter as ("NCR"), based in Henderson, Nevada, 89074, pursuant to 49 U.S.C. 10904(c) and 49 C.F.R. 1152.27(c)(2)(i), hereby formally expresses his intent to participate and file an offer of financial assistance by purchasing the combined lines identified by Michigan Air-Line Railway Co. hereby identified by this Petitioner as the (Wixom Industrial Lead)

from Milepost (45.26) at the west line of Haggerty Road to Milepost (50.65), a distance of Appx: 5.45 miles in Oakland County, MI.


2. By copy of this Notice, Robert Alan Kemp, D/B/A; NCR, pursuant to 49 C.F.R. 1152.27(a), asks the Michigan Air-Line Co. to provide it with copies of the most recent report on the physical condition of the line, the carrier's estimate of the net liquidation value of the line, with supporting data including, but not limited to specific identification and appraisals of the parcels of land underlying the rights-of-way which are owned in fee and those which are easement grants including in applicable [US-Government Granted Rights of Way], the lengths, weight, age and condition of the relay, reroll and scrap rails, the reusable and scrap ties, condition of all bridges, the speed limits on the line, and any other restrictions which pertain to the use of the line by Milepost, and any other information including Engineering Diagrams and Drawings, or Maps, and All Deeds, deemed relevant to enable NCR to calculate net liquidation value of the line and the minimum purchase price which the Michigan Air-Line Railway Co. seeks for the property.

3. As the Boards Decision entered February 17th, 2011 did Not specify and thus FIX a specific date in which a [NOTICE OF INTENT TO FILE OFA] would be filed by interested parties, but did affirmatively specify that an [OFA] would be Due within 10-Days of the Boards Decision in the event that the Board decides to Grant the Abandonment on or before May 18th, 2011. And moreover as of TODAY (Wednesday) March 16th, 2011, the Board has Not entered a decision in this proceeding, this Petitioner hereby files his NOTICE OF INTENT TO FILE OFA for which Petitioner understands will effectively and or alternatively legally stay the Abandonment Proceeding within this case. If Petitioners Understanding of this issue is incorrect, Petitioner hereby respectfully requests that the Board expeditiously decide and enter a decision providing further clarification as to the Points Regarding Timing for the Provision of an OFA relating to the May 18th, 2011 date previously mentioned by the Board on February 17th, 2011, and thus Accept and or Reject Petitioners instant NOTICE.




