Dear Ms. Brown:

It has been brought to the attention of CSX Transportation, Inc. (“CSXT”) that there are two references to Broadway Street in Exhibit 1 – Grade Crossing Identification, one in Harvey and the other in Blue Island. In Exhibit 2 – Grade Crossing Blockages, Broadway Street is referred to, but it is not identified as being in Harvey or Blue Island. CSXT clarifies that the references to Broadway Street in Exhibit 2 in Monthly Report No. 1 are all in Harvey. To avoid this confusion in Exhibit 2 in the future CSXT will identify Broadway Street in Blue Island as Broadway Street BI and Broadway Street in Harvey as Broadway Street H.
