Per our conversation of October 14th, 2011, I am writing to let you know that we did talk with Grenada Railway, LLC. about a guarantee of 80 rail cars per year after they made contact with us through a letter dated June 17th, 2011. In the letter they stated that 50 cars for three years would be enough to keep the line in service.

We became dissatisfied with the service when they got off the Tuesday night schedule they had agreed on and began sending cars twice a week. This resulted in us never knowing when the cars would be delivered or picked up.

For the first two months everything seemed to be working on a good schedule. They would bring the cars on a Tuesday night and that would allow us enough time to load the cars by the end of the week for them to pick up the following Tuesday night.

After repeated efforts on my part to discuss the problem with them, I called them back and told them I would no longer need the cars if I couldn't be assured that the cars would be delivered on the schedule I had discussed.


