EXPEDITED CONSIDERATION REQUESTED**

Dear Ms. Brown:

Wichita Terminal Association and related entities filed a Petition for Declaratory Order on October 18, 2013. Pursuant to 49 C.F.R. § 1104.13(a), Respondents' reply is due on November 7, 2013.

Respondents respectfully request, pursuant to 49 C.F.R. § 1104.7(b), 30 additional days in which to respond. Respondents need additional time to consider the arguments Petitioners have now made and determine how best to frame a reply in light of the lengthy record of proceedings that have occurred to date. In addition, Respondents will hire counsel that regularly appears before this Board and needs time to familiarize those attorneys with the evidentiary and procedural background of this dispute. Finally, this request is being made not less than 10 days before the due date. Respondents therefore seek 30 additional days. If this request is granted, Respondents' reply would be due on December 9, 2013. Respondents have sought Petitioners' consent but have not yet heard whether or not Petitioners will or will not consent to this requested extension.




