

Subject: California High Speed Rail Project Request for Permit and Public Hearing

Dear Ms. Brown:

We the residents of Acton and Agua Dulce, who reside in the County of Los Angeles, in the state of California are writing to oppose the Petition for Exemption ("Petition") filed by the California High Speed Rail Authority ("Authority"). For the reasons stated below, the Surface Transportation Board ("Board") should deny the Authority's Petition and require the Authority to apply for a Certificate from the Board as required by 49 U.S.C. Section 10901

We, the residents of Acton and Agua Dulce, California are concerned with the route that the California High Speed Rail Authority is taking in pursuing the California High Speed Rail Project (HSR Project). Residents of California were misled in 2008 when the Authority and the California Legislature requested that the voters of California approve a \$9.95 billion bond to support the HSR project. Under false information the voters approved this measure, which is commonly referred to as Proposition 1A and expected that a high-speed rail project spanning from San Francisco to Los Angeles with connection to Sacramento and San Diego would be built by 2020 for approximately \$38 billion. Over many iterations and manipulations the Authority plans to have initial operation service open by 2032 and the cost to only connect San Francisco to LA will be at a cost of \$68 billion. Further complicating the project is the fact that only \$6 billion has been identified for construction and the financing plan is dependent almost exclusively on private sector investment and the Federal government, of which neither has come to the table with any funds beyond the \$6 billion.

As much as this is an irresponsible project from a financial perspective, this project stands to have significant impacts on our semi-rural community. The proposed routes (three different alignments) will divide our community in half and will significantly impact our local existing public transportation systems, land use options, property values, our

wells, residences, businesses and schools, not to mention the significant noise impacts. We will not receive any direct benefits from the HSR with the nearest proposed station 20 miles north of us. The beginning of April 2013, over 900 of our Acton households received a letter from the HSRA asking permission for entrance on their property for the purpose of EIR studies and right of way access. There are 2,378 private residences in Acton so roughly 38% or 2886 of our Acton residents who received this letter are quite concerned about the possibilities of eminent domain by the HSRA. The remaining 62% are concerned that the HSR will completely destroy what is left of our community and our rural lifestyle. Many of our residents are on fixed incomes. The Authority has been non responsive to our concerns. We have attempted to have them meet with us for the past 4 months but have been unsuccessful in achieving this objective. The Authority has based their alignment decisions on early closed door meetings between politicians and engineers, which have lead to the alignments tunneling under our community right through our private wells, or traversing through the center of our community through the public Middle School and public High School. Our concerns to "save" our community have been downplayed or ignored by the Authority.

We plead with you to open this project for a full investigation. Many Californians are expressing their concern for the fiscal disaster that the HSR may be creating for all future California taxpayers. Per your duties as an agency to oversee passenger rail service and freight rail service, this project has a significant probability of creating numerous negative impacts. As part of this investigation we also would like to request that it be carried out in a public manner, with all attempts for hearings to be held in California. The public has continually been misled by the Authority staff and has had to work diligently to counter the misinformation being provided by the Authority staff and cadre of consultants. The public should be afforded all opportunity to relay concerns and issues with your board.
