1. James Riffin (“**Riffin**”) filed a Confidential Portion of his Reply to Jersey City’s, et. al., Motion to Strike Riffin’s Notice of Intent to File an OFA.

2. The Confidential Portion discusses:

- A. A short history of the Harsimus Branch.
- B. A summary of the litigation to date.
- C. Some discussion regarding shipper interest, the feasibility of providing freight rail service, and community support.
- D. Some concerns of Riffin regarding an OFA submitted by Jersey City.
- E. The common, and dissimilar, goals of Riffin and Jersey City.
- F. Riffin’s and Jersey City’s Plans for Continued Freight Rail Service.
- G. Sites where freight rail transload services could be provided.
- H. The estimated costs of providing rail transload sites.
- I. The OFA ‘taking’ criteria.
- J. Financial responsibility of Riffin and Jersey City.
- K. Riffin then concludes that the criteria for filing an OFA have been met. (There is shipper interest / it is economically feasible to provide freight rail service / there is communtiy support / both Riffin and Jersey City intend to actually provide freight rail service.)
- L. The STB should permit both Jersey City and Riffin to file an OFA, so that Conrail has the option of picking from more than one OFA offeror, with whom it will negotiate.
