

 Board, Washington, DC  
 20423, a notice of exemption  
 under 49 CFR 1152 Subpart  
 F-Exempt Abandonments,  
 permitting the abandonment  
 and discontinuance of serv-  
 ice, respectively, of a 1.5  
 mile line of railroad in the  
 Central Region, C&O Divi-  
 sion, Toledo Subdivision, be-  
 tween railroad Milepost QED  
 114.1, which traverses  
 through United States Postal  
 Service ZIP Code 43015, and  
 railroad Milepost QED 115.6  
 in Delaware County, Ohio.  
 The proceeding has been  
 docketed as No. AB-565  
 (Sub-No. 8X) and AB-55  
 (Sub-No. 608X).  
 The Board's Section of Envi-  
 ronmental Analysis (SEA)

 matters should be filed no lar-  
 er than 15 days after the EA
