

WISCONSIN CENTRAL LTD. -- ABANDONMENT EXEMPTION --
IN CALUMET AND BROWN COUNTIES, WISCONSIN

**JOINT MOTION OF WISCONSIN DEPARTMENT OF
NATURAL RESOURCES AND WISCONSIN CENTRAL LTD
FOR EXTENSION OF TIME TO REACH AN AGREEMENT ON
AN INTERIM TRAIL USE/RAIL BANKING AGREEMENT**

On October 2, 2000, the Wisconsin Central Ltd. (WCL) filed with the Surface Transportation Board (Board) a petition to abandon a line of railroad known as the Hilbert-Greenleaf Line, between milepost 170.4 at Hilbert and milepost 183 at Greenleaf, in Calumet and Brown Counties, WI, a distance of 12.6 miles. The line traverses U.S. Postal Service Zip Codes 54129, 54123, and 54126 and includes station at Greenleaf (milepost 183).

On July 20, 2000, the Wisconsin Department of Natural Resources signed a Statement of Willingness to Accept Financial Responsibility pursuant to 49 C.F.R. § 1152.29. This statement is for the segment of WCL railroad line at Hilbert Milepost 170.0¹ to Greenleaf Milepost 183.0, a distance approximately 13 miles in Calumet and Brown Counties, Wisconsin.

¹ Although the WisDNR's Statement of Willingness, for the portion of line from Hilbert Milepost 170.0 to Greenleaf Milepost 183.0, WCL's Petition for Exemption is for the line of railroad from Hilbert Milepost 170.4 to Greenleaf Milepost 183 and thus the NITU request will be for the same segment.

On November 9, 2000, the Wisconsin Department of Transportation on behalf of the Wisconsin Department of Natural Resources filed a request for a notice of interim trail use/rail banking (NITU) under 16 U.S.C. 1247(d) and 49 CFR 1152.29. WCL indicated its willingness to negotiate with WisDNR for interim trail use.

The Board issued a NITU under 49 CFR 1152.29, which was served on January 19, 2001, allowing the WisDNR the full 180 days from date of service to negotiate a rail banking agreement with WCL. The 180 day period under NITU was scheduled to expire on July 18, 2001.

On July 13, 2001, WisDNR/DOT and WCL jointly filed a motion to extend the NITU negotiating period for an additional 180 days. The Board issued a NITU under 49 CFR 1152.29, which was served on July 17, 2001 allowing the parties until January 14, 2002 to negotiate a trail use agreement.

On December 26, 2001, WisDNR/DOT and WCL jointly filed a motion to extend the NITU negotiating period for an additional 180 days. The Board issued a NITU under 49 CFR 1152.29, which was served on January 11, 2001 allowing the parties until July 13, 2002 to negotiate a trail use agreement.

On July 2, 2002, WisDNR/DOT and WCL jointly filed a motion to extend the NITU negotiating period for an additional 180 days. The Board issued a NITU under 49 CFR 1152.29, which was served on July 11, 2001 allowing the parties until January 9, 2003 to negotiate a trail use agreement.

On December 23, 2003, WisDNR/DOT and WCL jointly filed a motion to extend the NITU negotiating period for an additional 180 days. The Board issued a NITU under 49 CFR 1152.29, which was served on July 11, 2001 allowing the parties until July 8, 2003 to negotiate a trail use agreement.

WisDNR has made an initial contact with WCL to negotiate a trail use agreement. Negotiations will continue in good faith between WisDNR and WCL. However, more time is needed to finalize negotiations. WCL is agreeable to an extension of time to continue negotiations.

MOTION

Therefore, WisDNR and WCL move that the period prescribed to negotiate an interim trail use/rail banking agreement be extended for 180 days for the land corridor and related real property, including bridge structures, on a line of railroad known as the Hilbert-Greenleaf Line, between milepost 170.4 at Hilbert and milepost 183.0 at Greenleaf, in Brown and Calumet Counties, WI, a distance of 12.6 miles for interim trail use and rail banking.
